



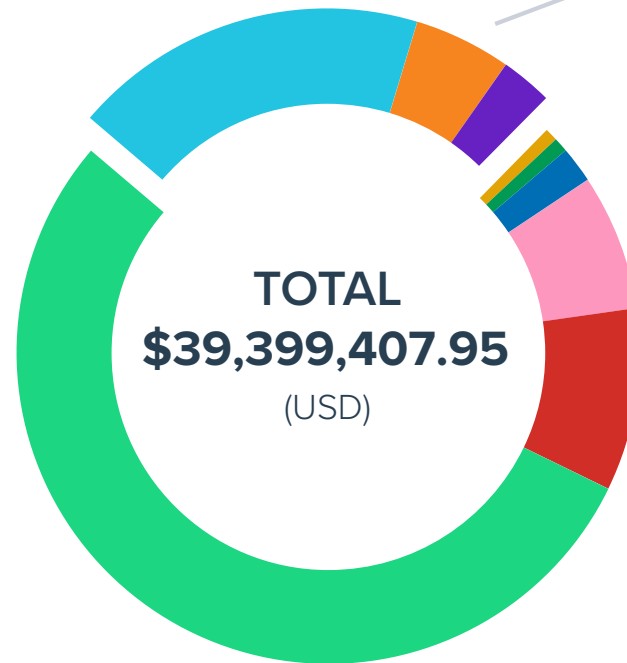
Introduction

Since 2008, the Global Programme on Strengthening the Rule of Law and Human Rights for Sustaining Peace and Fostering Development has provided assistance on rule of law and human rights in over 50 countries, territories and regions. The current operational phase of the Global Programme began in January 2017 and was completed in 2021. This section provides an overview of our financial support mobilized and delivered in 2021, as well as over the lifetime of the Global Programme. Further, this section provides an overview of the country/territory project allocations made, as well as the 2021 budget for programme and policy work undertaken by UNDP’s Rule of Law, Justice, Security, and Human Rights team with detailed activities that were delivered (both globally and at the country/territory level). 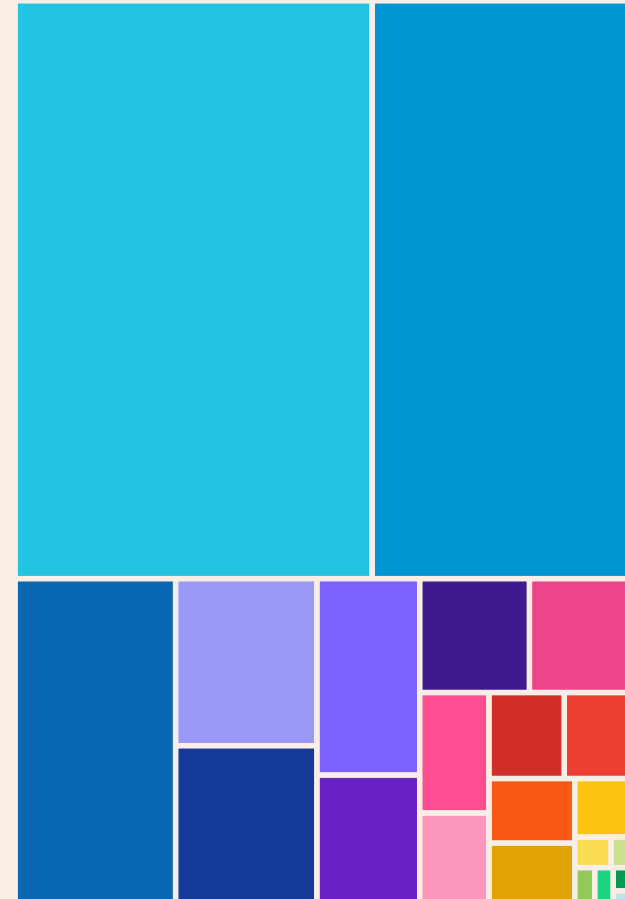

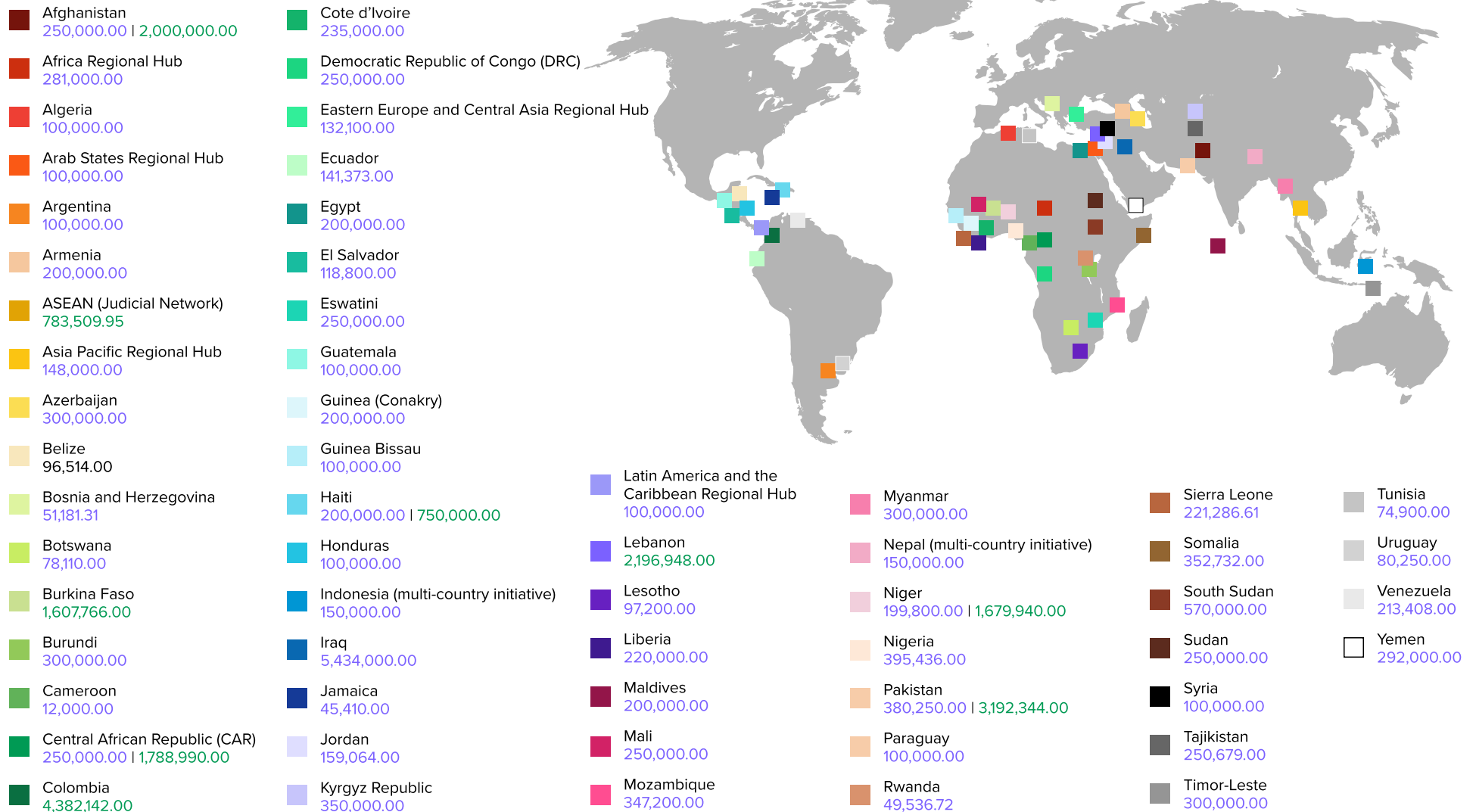

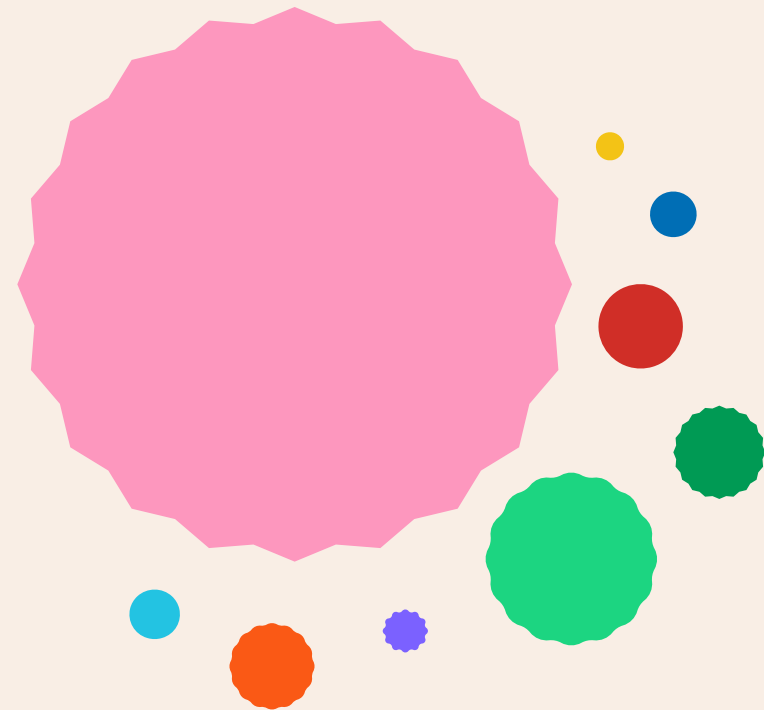
